Maryn Boess KEYNOTE



Over her 35+-year career in the nonprofit world, Maryn has been an on-staff program developer and grantwriter; an independent grants consultant (winning more than \$42 million for her clients over 10 years); a grants project manager; a grants trainer; a grants reviewer, author, speaker, mentor and coach; and - starting in 2006 - even a grantmaker.

This done-it-all background gives her the *unique 3-D "insider's" perspective* she brings to the practical and inspiring trainings on healthy, successful grantsmanship that she has been blessed to share with thousands of non-profits of every size, nationally and internationally as well.

GrantsMagic U, launched in fall 2015, is the "virtual academy" she created to make her extensive portfolio of grantsmanship trainings available (and affordable!) for anyone, anytime, anywhere. GrantsMagic U's global student community now includes over *45,000 people from at least 34 countries*, including all 50 U.S. states, DC, Puerto Rico, Guam, and the Virgin Islands. GrantsMagic U is an Approved Continuing Education Provider for both the Grant Professionals Certification (GPC) and Certified Fund-Raising Executive (CFRE) credentials. GrantsMagic U is also one of the original "Approved Trainers" for the Grant Professionals Association.

Starting in 2006 Maryn has also been "in the grantmaker's chair," managing up to \$2 million annually as a grantmaker for K-12 education in the U.S. Southwest. She considers herself a dual citizen in the grants world, and may be the only person to hold simultaneous membership in both GPA (Grant Professionals Association, for grantseekers) and GEO (Grantmakers for Effective Organizations, for grantmakers).

In 2020, in recognition of her longstanding service and contribution to the grant profession, Maryn became just the second person ever to be inducted into the international *Grant Professionals Class of Distinguished Fellows*.



Adam Arents

Adam's brief experience as a grantwriter yielded a total of one grant for \$1,000 that he secured for a nonprofit early in his career, which he was pretty proud of at the time. After that, he worked in the Chicago Public Schools Partnerships Office before teaching English on a Fulbright grant in Russia and then developing new digital strategies at Rotary International. He's been supporting education and youth development across the Chicago area as a Program Officer for the IMC Chicago Charitable Foundation since 2016.



Dale Asis

Dale Asis is the Finance Director at Little Village Environmental Justice Organization. Dale is also the President of the Bayanihan Foundation Worldwide, a US registered public charity dedicated to promoting Filipino diaspora philanthropy. Additionally, Dale is the founder of two coalitions: The Coalition of African, Arab, Asian, European and Latino Immigrants of Illinois (CAAAELII) and United Congress of Community and Religious Organization (United Congress). In 2009, he established a network of over 150 diaspora donors in

Chicago that donate to over 50 countries worldwide. He earned his Master of Arts Program in Social Sciences (MAPSS) at the University of Chicago. He is currently teaching and completing his PhD at Loyola University Chicago. In 2007-08 he received a fellowship grant from the Chicago Community Trust Fellowship for Community Leaders. Mr. Asis also received the Ford Foundation Leadership for a Changing World Award. Over the last 18 years, Dale has spoken extensively on immigrant and diaspora philanthropy issues. He also provides capacity building and organizational consulting to many ethnic community organizations in Chicago.



Yusef Garcia

Yusef Garcia's mission is to help build and transfer power, one relationship at a time. Currently, he serves as Founder and principal of Monarq Advisors, a people-centered advisory firm helping organizations and individuals successfully develop strategies that address their unique needs; such as transformative revenue generation, coaching for rising leaders, governance support, and convening.

Prior to embarking on Monarq Advisors, Yusef served as an executive non-profit leader (serving in philanthropic, intermediary, health + human services, and arts & culture spaces) architecting the development and implementation of contemporized fundraising, engagement, and partnership strategies. He also currently serves as Vice Chairelect at AFC (AIDS Foundation of Chicago).

In addition to his passion for influencing change, Yusef is a trained chef, having graduated from the Culinary Institute of America in Hyde Park, NY. He also enjoys photography, travel, and Chicago House Music. He and his husband live in Chicago with their two pups.

Caroline McCoy

Caroline McCoy's professional interests and passion include supporting community-driven strategies that influence equitable services, systems, and practices, and advancing racial justice in philanthropy. She currently serves as Vice President of Programs at the Woods Fund where she supports work that is advancing racial equity and economic justice through grantmaking.

Prior to joining the Woods Fund, Caroline was a Program Officer at the Robert R. McCormick Foundation, where she led the Foundation's place-based initiative in Englewood and its health and wellness funding strategy. She also managed relationships with corporate partners to help them achieve impact in their local communities.

Previously, Caroline was an Associate Director at Arabella Advisors where she supported family and individual clients to build and implement grant-making strategies across several issues. She also worked at the Ounce of Prevention Fund, where she supported advocacy efforts to improve services for young children and families in Illinois.

She holds a BA in political science with a minor in African American studies from the University of Illinois at Urbana-Champaign and a MS in public service management from DePaul University. She is a former ABFE Connecting Leadership Fellow and BMe Vanguard Fellow and serves on the Board of Directors for the Chicago Lawyers' Committee for Civil Rights, and the executive leadership team and Social Justice Committee Chair for Chicago African Americans in Philanthropy.



Laura Stukel

Laura Stukel has deep expertise as a market transformation, stakeholder, and leadership consultant for the energy efficiency industry. Her project management and content experience led to successful outcomes in several public-private market transformation projects including efforts to increase consumer demand for energy efficiency by highlighting benefits throughout the sales process for residential homes. Laura uses a foundation of building performance

concepts, including climate requirements, whole home performance, and health and safety benefits to extend knowledge sharing from building scientists to the supporting program managers, contractors, community advocates and other leaders that engage with consumers to make home energy upgrades possible.

More recently, Laura has extended her work based on experience in working with the UN Sustainable Development Goals, and the Justice 40 initiative, particularly around the design of Community Benefit Plans and Market Transformation Plans.

Several high-profile projects include: project co-manager for U.S. Department of Energy Better Buildings Home Energy Information Accelerator; project and stakeholder manager and lead author for both the proof-of-concept blueprint resource, Capturing the Sun: A Roadmap for Auto-Populating Solar Home Sale Listings (U.S. Department of Energy Lawrence Berkeley National Laboratory, 2017); and the consensus building science definition resource, Green MLS Implementation Guide (National Association of Realtors, with Real Estate Standards Organization, 2014). Applying a model for social change ecosystems, Laura has expertise in recruiting, connecting, managing and leading cohorts to build knowledge and skills while solving market-based problems together.

Charting an Uncharted Territory: Understanding Our New Era of Funding


